The Operations Branch is broken down into (2) two divisions, Operations and Hazardous Material/Medical. The Operations Division is overseen by Assistant Chief Russ Lafferty and assisted by Battalion Chief Jared Melton. These gentlemen are responsible for the operations and supervision of fire stations, apparatus, firefighting personnel and fire ground operations at incidents. The Hazardous Material/Medical Division is overseen by Assistant Chief Dennis Clinton. Asst. Chief Clinton is responsible for the medical and hazardous material policies and protocols, operation and readiness of the hazardous material response personnel, medical and hazardous material equipment and personnel training.

In 2011 the Operations division responded to 1,334 calls for service. This is a **6.0% increase** over the previous year. This increase can be contributed to several different areas but mainly due to the automatic aid responses to several jurisdictions. These automatic aid responses are reciprocal in nature as other jurisdictions respond into our district to help us. Additionally, these automatic aid agreements help in manpower shortages but also save significant property for the constituents.

To increase our services for the constituents we have joined forces with the City of Springfield Fire Department and the Battlefield Fire Protection District in water rescue. Springfield Fire Department has served the area as the leading agency in water rescues for numerous years and has extended an invitation to us to join their team. The district has assigned three members from each shift to be members of the team. Team members will finish the water rescue technician certification in early spring of 2012.

In conclusion it has been a very exciting and busy year for everyone with the anticipation of continued growth in the district. We look forward in the upcoming year to serving our residents and those traveling through or visiting.

The Technical Service Branch consists of three (3) Divisions:

Public Education/Relations
Training
Fire Prevention

The Technical Services Division continued to focus on an all hazards approach to fire & injury prevention in 2011. Our ***Community Risk Reduction*** efforts were strengthened by an additional grant from the NFPA to add an additional home health agency to our *Remembering When* partnership. In addition to St. John's Home Health we will now have Oxford Healthcare as a partner in reducing falls and fires in the homes of older adults throughout our district. We will also be assisting in continuing education workshops to train all of Oxford's 700 field staff employees in the *Remembering When* curriculum.

We had a very successful grant & scholarship year with the fire district receiving over \$37,000.00 in money from various agencies for equipment and training. The Technical Services Division was able to place in service an inflatable fire safety education house that will enhance our efforts in reaching the community. Additionally, we were able to purchase 300 dual sensor smoke alarms and 20 hearing impaired smoke alarms. We also received another allotment of nine volt batteries from the Energizer Company.

In August we held the 2nd annual Pancakes & Pencils event to support the Wildcat Closet and the Rogersville chapter of Care to Learn. Through community partnerships and individual donors we were able to raise \$2500.00 dollars for these two organizations, which provide assistance to children throughout our district. A successful Firefighter I & II class was held in 2011 with a 94 % pass rate. In conclusion it was a very busy year for the Technical Services Division with many exciting things taking place. We will continue to push forward in 2012 with our focus on Community Risk Reduction.

1. We installed eighty-two (82) smoke alarms in seventy-six (76) single-family dwellings. We also installed sixty-six batteries in fifty (50) single-family dwellings. In 2012 we will be canvassing target neighborhoods as we strive to ensure that every family has a working smoke alarm.

2. Carbon Monoxide Detectors (CO). This program continues to be successful through a community partnership with Home Depot. We installed six (6) CO Detectors in six (6) single-family dwellings.
3. We continue to offer the Residential Safety Survey (RSS) program four our constituents. We conducted forty-four (44) Residential Safety Surveys in 2011. In 2012 we hope to conduct these surveys during every smoke alarm installation.
4. Engine Crews continue to conduct blood pressure screenings at the Rogersville Senior Center bi-monthly. Engine Crews see on average twenty-two older adults on these scheduled days.
5. The Child Passenger Safety program has flourished over the past year. We have seen an increase in installation requests and check only requests. In 2011 we installed forty-two (42) child safety seats and checked twenty-one (21) already installed car safety seats. We will be hosting a regional CPS-Technician class in April of 2012.
6. The Mobile Fire Safety Learning Center (MFSLC) was placed in service at seven (7) events. This year over 1,100 children were educated through realistic educational sessions. We are continuing to work with Home Depot to complete some much needed renovations and updates to the MFSLC in 2012.
7. We provided two (2) EMS standbys at requested events.
8. We provided four (4) fire standbys at requested events.
9. We continue to work very closely with the school district in reaching the school aged children that reside in our district. In 2011 we visited over 1, 350 students in the schools with important fire safety messages and injury prevention information.
10. We continue to assist the school district in parking vehicles at all home football games and graduation. This year we saw another successful football season which led to increased attendance at home football games.
11. District Headquarters was toured twenty-five (25) times this year.
12. We held the 2nd Annual Pancakes & Pencils event in August as a school supply drive for the Wildcat Closet and as a direct fundraiser for the Rogersville Chapter of Care to Learn. Several hundred people came out to support the event and the community.
13. The fire district hosted several birthday parties and monthly service group meetings in the training/community room.
14. Community CPR/AED education was provided to six (6) places of business and three (3) civic groups. The total number of students educated was eighty (80).

Training:

In 2011, Logan-Rogersville personnel received 2,624 hours of training. Logan-Rogersville personnel received the following certifications: The total number of current certifications is also shown below.

Fire Prevention:

This year the Fire Prevention Division conducted the following activities:

- Completed two-hundred and twenty-one (221) annual inspections in commercial buildings.
- Our re-inspection percentage continues to drop with owners and tenants recognizing the need to maintain their properties at a higher level.
- A total of three (3) sets of building plans were reviewed for new construction throughout the district. This included plans that were sent back for a second review after changes.
- Our Knox Box program continues to grow. We have seen a steady increase in Knox Key switches being ordered. This is mainly from a partnership with local gate contractors.

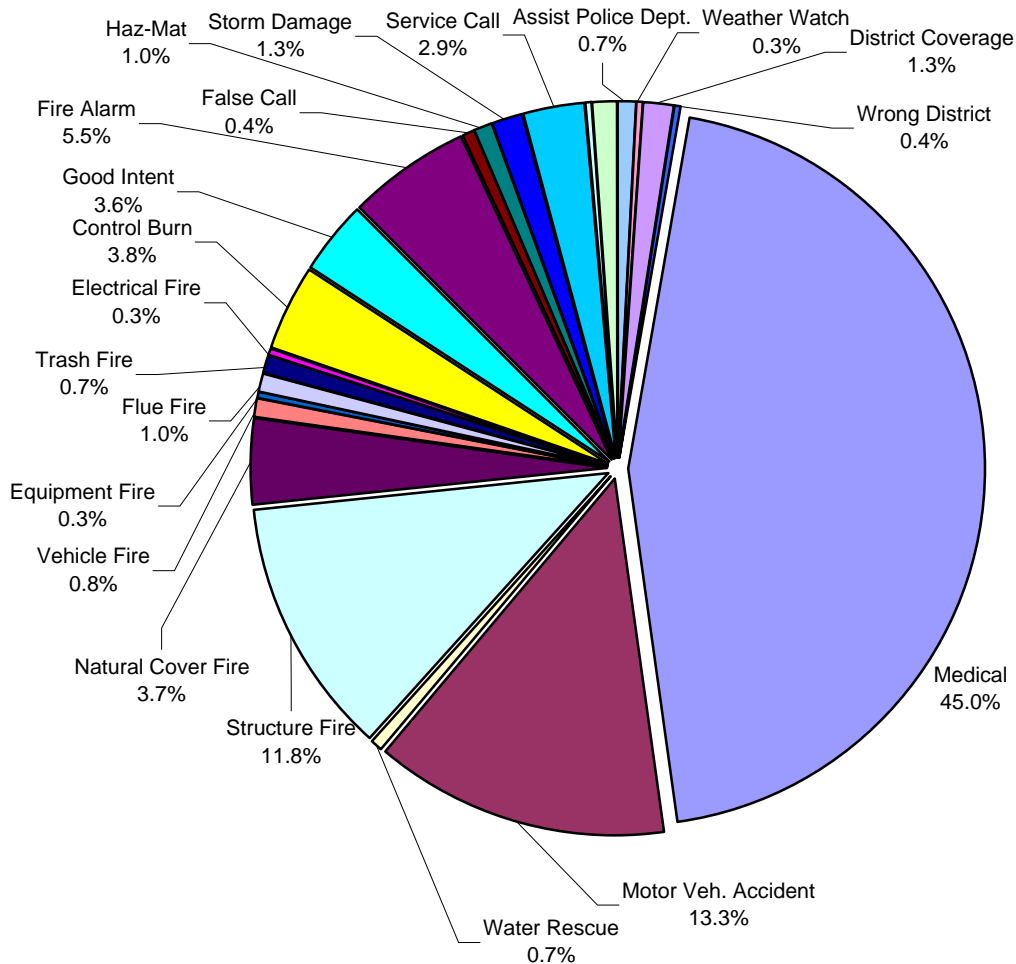
- A total of seven (7) permits were issued for public display of fireworks. Each of these permits requires a field inspection. We receive a permit fee of \$100.00 for each display.

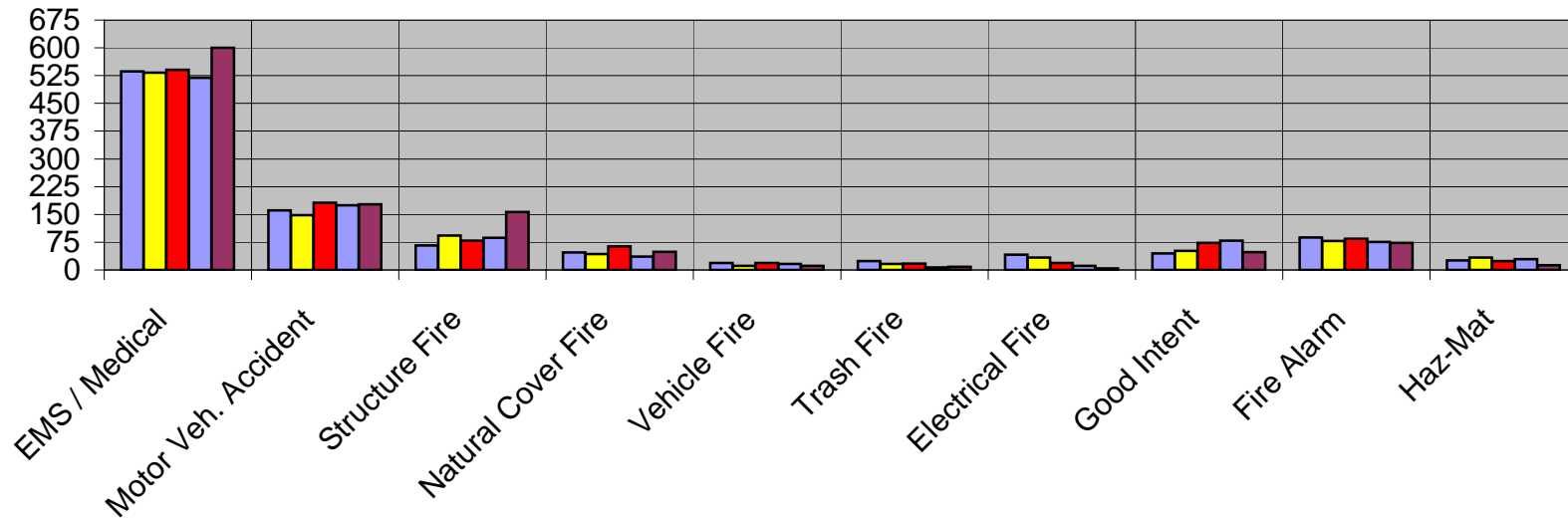

TYPE OF EMERGENCY CALLS PER YEAR > 2007 THROUGH 2011 <



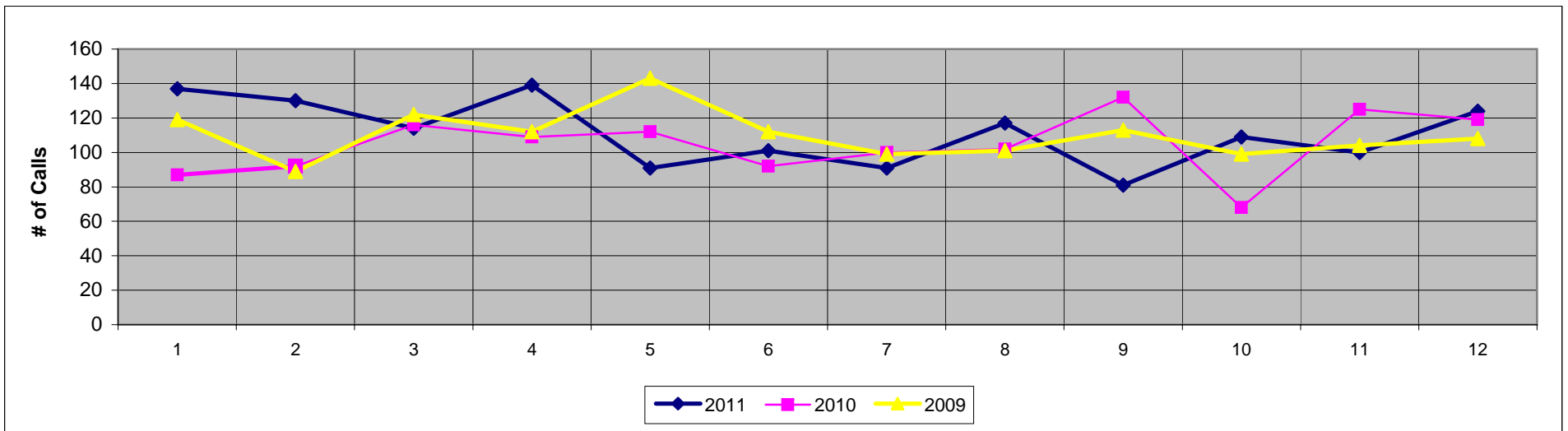

NUMBER OF EMERGENCY CALLS PER MONTH > 2009 THROUGH 2011 <



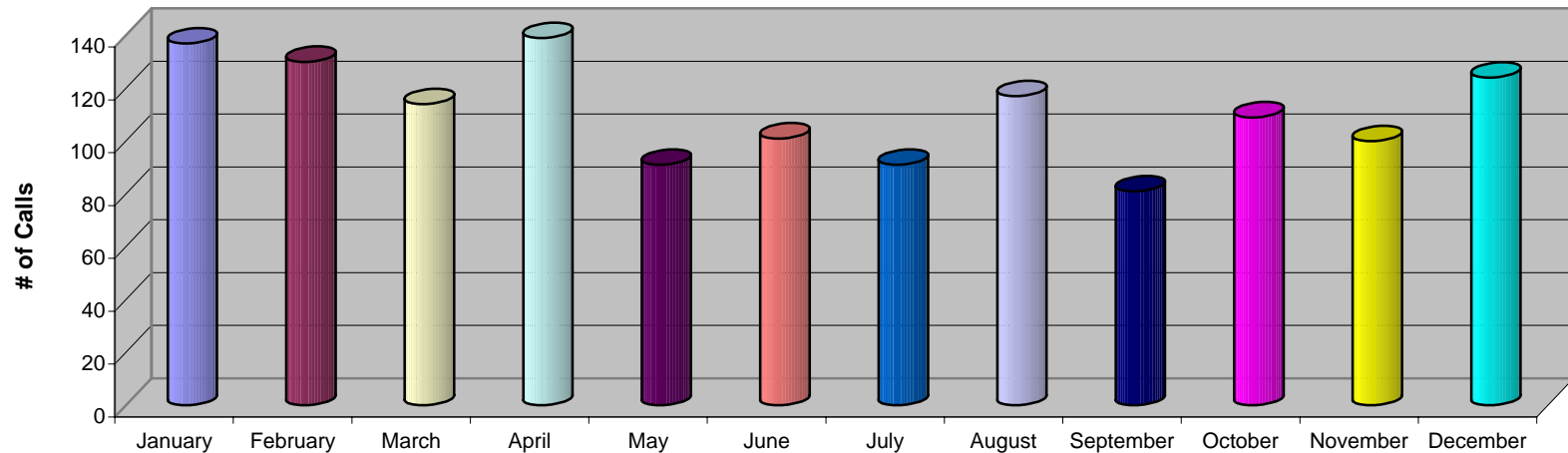

NUMBER OF EMERGENCY CALLS PER MONTH DURING THE YEAR OF 2011



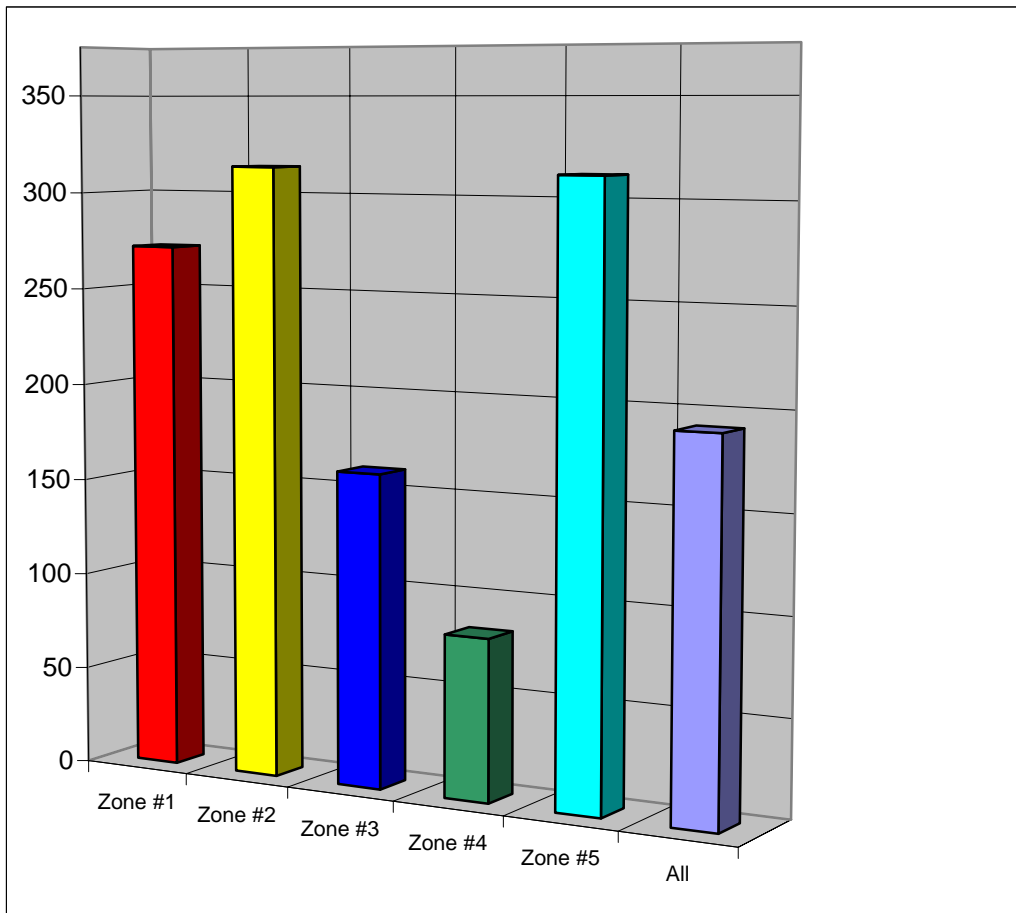

EMERGENCY CALLS RUN PER STATION ZONE DURING THE YEAR OF 2011



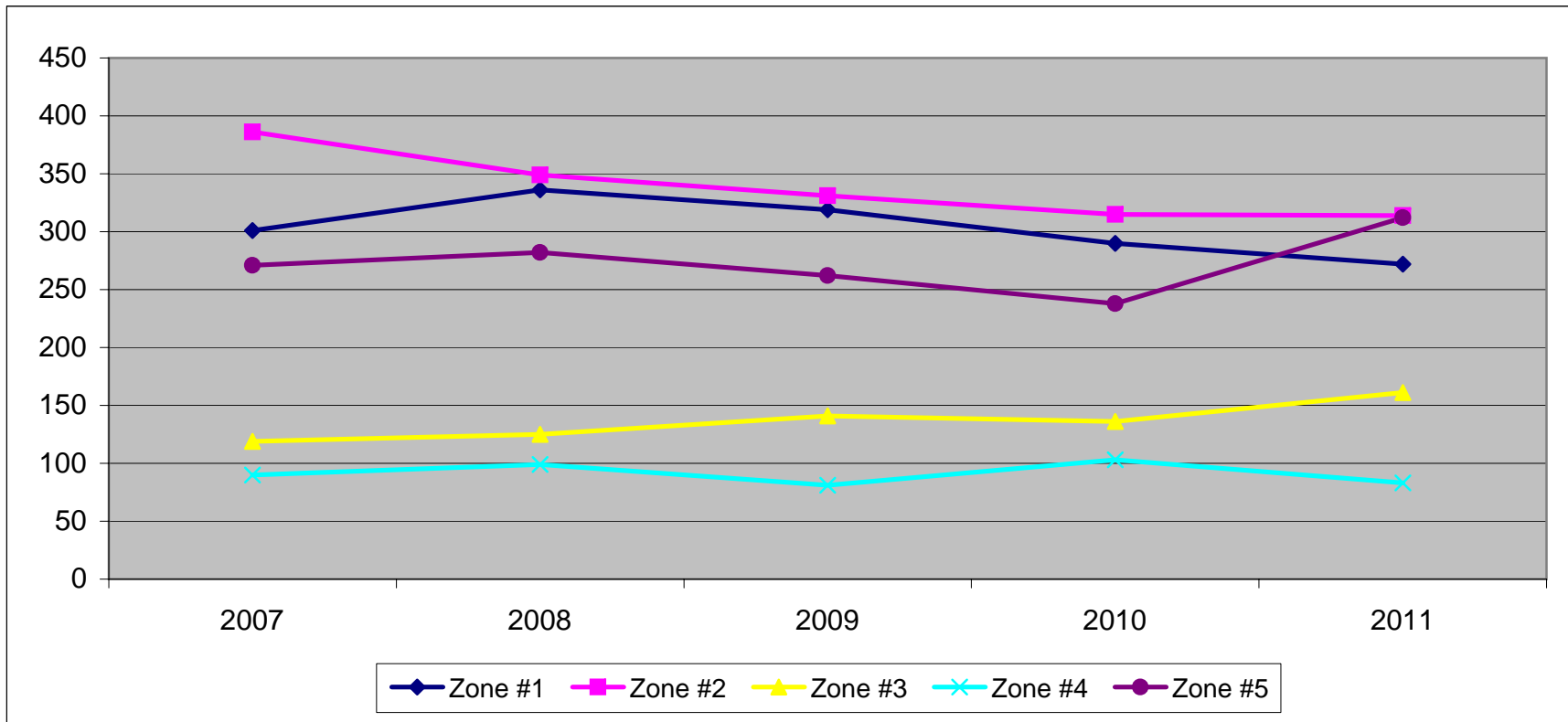

EMERGENCY CALLS RUN PER STATION ZONE > 2007 THROUGH 2011 <



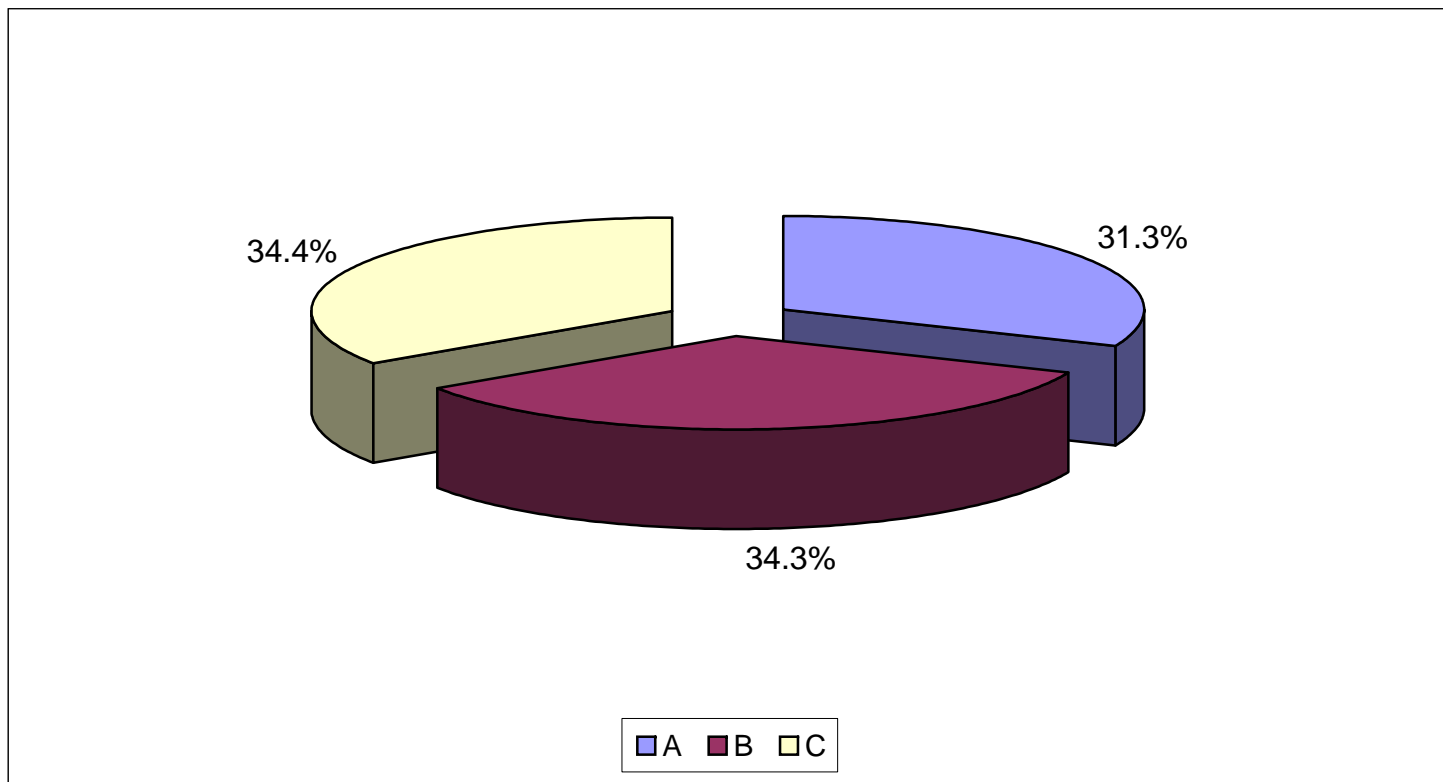

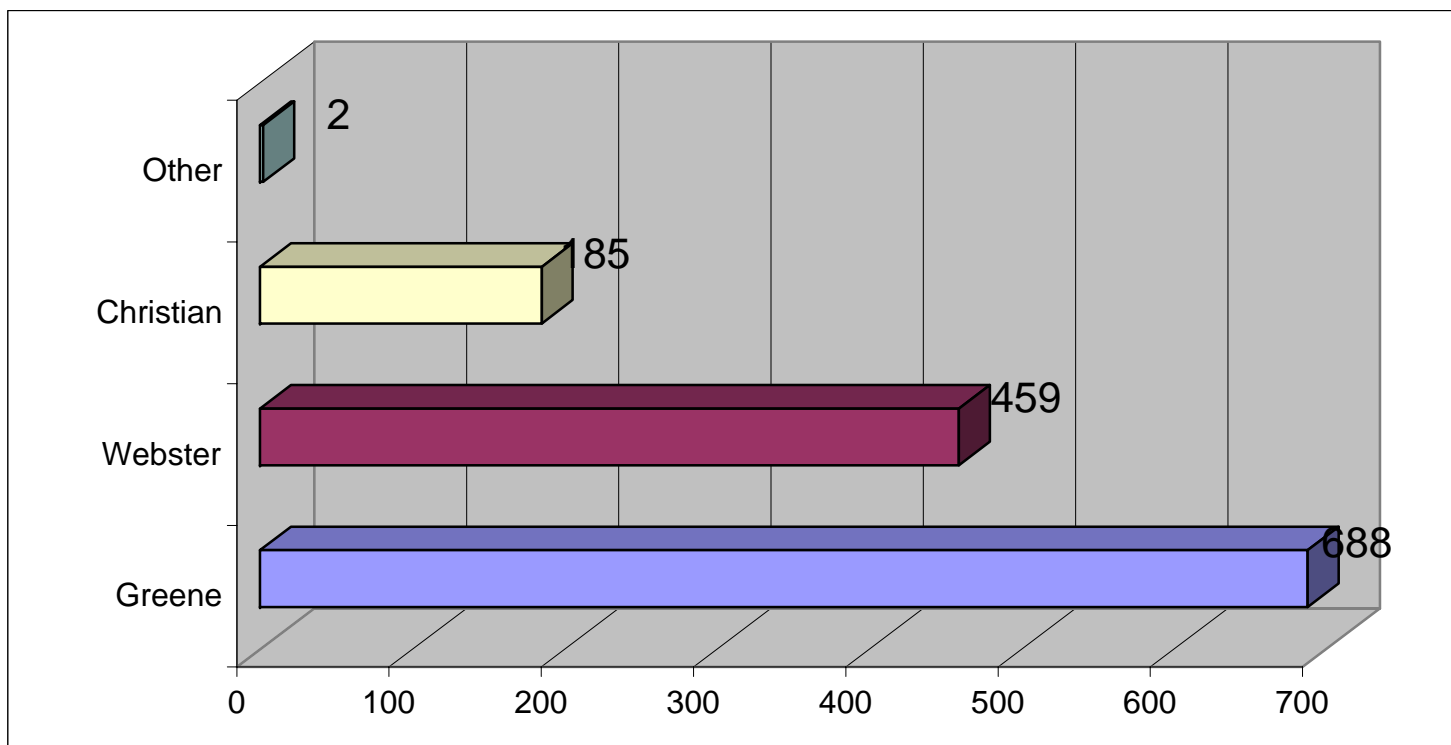
