

AN ORDINANCE ADOPTING THE INTERNATIONAL CODE COUNCIL (ICC) 2018 FIRE CODE, EXCLUDING SECTION 903.3.1.3 REGARDING SPRINKLERS IN CERTAIN RESIDENTIAL HOMES, IN THE LOGAN-ROGERSVILLE FIRE PROTECTION DISTRICT, MISSOURI

WHEREAS, the Logan-Rogersville Fire Protection District, Missouri is a political Subdivision, duly organized and existing under the laws of the State of Missouri; and

WHEREAS, the Board of Directors of the Logan- Rogersville Fire Protection District have determined that it is in the best interests of the District to adopt the ICC 2018 Fire Code, excluding Section 903.3.1.3 for the safety of the citizens of the Logan-Rogersville Fire Protection District.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE LOGAN-ROGERSVILLE FPD, MISSOURI, AS FOLLOWS:

Section 1:

The ICC 2018 Fire Code, excluding Section 903.3.1.3 is adopted by the Logan- Rogersville FPD, and is hereby incorporated by reference and made a part of the ordinance book of the Logan-Rogersville FPD, Missouri, as fully as if set out in their entirety therein.

Section 2:

The provisions of the ICC 2018 Fire Code excluding Section 903.3.1.3, and any referenced standards thereto, and Appendices thereto, if any, shall govern all construction within the District.

Section 3:

Any person, fire, corporation, partnership, or other lawfully recognized entity who violates the provisions of such codes hereby adopted shall be guilty of an offense and shall, upon conviction, therefore, be deemed guilty of a misdemeanor and shall be fined in a sum of not more than five hundred dollars (\$500.00) or by imprisonment not to exceed one hundred eighty (180) days, or both such fine and imprisonment. Each day said violation continues shall constitute a separate and distinct offense for purpose of ascertaining and imposing such fine and/or imprisonment.


Section 4:
